# Bill Mills shares impressions from People to People trip to Cuba

Cuba is very much a country of haves and have-nots, Bills Mills told Rotarians as he recapped a recent group trip to the island nation (population 11.5 million) organized by People to People International.

Since the U.S. lifted travel restrictions, Americans have been flocking to the land of the late dictator Fidel Castro. People to People was founded in 1956 by

President Dwight Eisenhower to promote international peace and understanding (much like Rotary). Bill said there were 19 people in his tour group, headed by former Kansas City Mayor Kay Barnes. To travel to Cuba, Americans must do so under either a medical or educational purpose, but as Bill said, "Really, it's tourism to get our money."

Bill noted that Rotary has not yet returned to Cuba, but there may be some hope given that the Rotary has made a comeback in countries like Russia and China.


Using slides from his trip, Bill offered the following observations about Cuba:



- The country has two currencies, a convertible peso or CUC, and a local peso, or CUP. It costs tourists 13% to exchange money, all of which goes to the government.
- Everybody works for the government in one way or another. Most people get a government salary of 20 CUPs (local pesos) a month, equivalent to \$20. People need more than this to survive, so they sell goods to tourists. The black market is rampant in almost everything.
- Sugar cane is the major crop, employing many people who often live in highrise apartment buildings.
- Education and medical care are free, but as with other things in Cuba, there are two systems, one for the haves and the other for the have-nots.
- Many tourists never see the "real" Cuba. Canadians and Europeans, who have been free to travel to Cuba for many years, typically stay at upscale resorts on a well-manicured and gated peninsula with a separate airport.

All in all, Bill did not feel the trip was worthwhile because there was no humanitarian purpose and all he did was support the Cuban government with his money.
